I either did not click the “support” icon at all, or I did so accidentally. I do not believe that I did it accidentally. So, after learning of this issue last night, I logged into LinkedIn, searched for the post based on the screenshot, and tried to make sure that the support icon was not “clicked on.” I then reported the suspicious activity to LinkedIn. Today, my account was locked when I attempted to log in to check the status of my suspicious-activity report.

I had prepared this letter before I received the Motion for Recusal filed this evening. I will read that motion carefully and take the matter under advisement. These actions are stayed pending resolution of the Motion for Recusal.
